Candidates for the following offices shall file with the county clerk to attain ballot access and should contact the county clerk of their county of residence for filing procedures and requirements: Circuit Clerk, Commonwealth Attorney in single county circuits, County Judge Executive, County Clerk, County Attorney, Sheriff, Jailer, Coroner, Property Valuation Administrator, Surveyor, Magistrate/Justice of the Peace, County Commissioner, Constable, Soil and Water Conservation District Supervisor, Mayor, City Legislative Body, and Board of Education.

Candidates for the following offices shall file with the Office of the Secretary of State: President of the United States, Vice President of the United States, United States Senator, United States Representative in Congress, Governor, Lieutenant Governor, Secretary of State, Attorney General, Auditor of Public Accounts, State Treasurer, Commissioner of Agriculture, State Senator, State Representative, Supreme Court Justice, Judge of the Court of Appeals, Circuit Judge, District Judge, and Commonwealth Attorney in multi-county circuits.

Following are guidelines for candidates filing with the Office of the Secretary of State:

1. Complete all applicable blanks on the filing form. The Office of the Secretary of State will make the necessary copies for distribution.
2. If the filing form requires notarization, the candidates and signers must have their signatures acknowledged by a Notary Public and the expiration date of the notary's commission must be stated.
3. All copies of form KREF-001, Statement of Spending Intent and Appointment of Campaign Treasurer (**not applicable to Federal Candidates who must register with the Federal Election Commission**) should accompany the filing form. Please see the attached instructions from KREF regarding the filing of the KREF-001 form.
4. Checks should be made payable to the Kentucky State Treasurer.
5. Candidates may file in person or by mail at the following address:

PRESIDENT/VICE PRESIDENT INDEPENDENT and POLITICAL GROUP AND ORGANIZATION CANDIDATES GENERAL ELECTION

The Office of President/Vice President of the United States will appear on the 2024 general election ballot.

Signatures Required:	Each candidate's signature and the signature of 5,000 registered voters from the district or jurisdiction in which candidate seeks nomination.
Earliest date to affix signatures on Nominating Petition	November 8, 2023
Earliest date to file Nominating Petition	November 8, 2023
Latest date to file Nominating Petition (4:00 p.m., local time)	June 4, 2024

Filing Form SBE 64 and SBE 64-2	Nominating Petition
Filing Fee	\$500.00
Filing Official	Secretary of State

Political Organization Definition: "Political organization" means a political group not constituting a political party within the meaning of subsection (1) of this section but whose candidate received two percent (2%) or more of the vote of the state at the last preceding election for presidential electors. KRS 118.015 (8).

Political Group Definition: "Political group" means a political group not constituting a political party or a political organization, within the meaning of subsection (1) and (8) of this section. KRS 118.015 (9)

All candidates seeking the offices of President/Vice President, other than those candidates who have been nominated by a qualified party or political organization, must file a Nomination Petition (SBE 64 and SBE 64-2) with the Office of the Secretary of State. A qualified political party or political organization may nominate candidates by convention or primary held in accordance with its constitution and bylaws and file a Certificate of Nomination in lieu of a Nominating Petition.

The Nominating Petition shall be signed by the candidate for President and the candidate for Vice President and by a minimum of **5,000** registered voters from the district or jurisdiction from which the candidates seek nomination. Petitioners shall be registered voters and shall include the date the petition was signed, date of birth and residence address. Signatures **shall not be affixed** prior to the first Wednesday after the first Monday in November of the year preceding the year in which the office will appear on the ballot.

As provided on the Nominating Petition, petitioners will further place in nomination a list of presidential electors providing the name, residential address and signature of each presidential elector.

The names of candidates for President/Vice President shall be certified in lieu of certifying the names of the candidates for presidential electors.
