Dear Ms. Bomar:

I am enclosing an annual report form for the subject corporation for the following years: 1970, 1971, 1972, 1973, 1974, 1977, 1981, during which the corporation failed to pay its annual report fee of \$2.00 per year. Please have the corporation complete and execute the enclosed form and return to this office along with a check for \$14.00, payable to Kentucky State Treasurer.

In compliance with KRS 273.367, this office will notify the corporation of impending revocation of the corporate charter because of failure to file back due annual reports. The corporation will have six months from the date of that letter in which to pay back due reports and thus prevent revocation. At the present time, the corporate agent for service of process is listed in our files as Maxine S. Huskamp, 2132 Lakeside Drive, Louisville, Kentucky. I am enclosing a form for change of process agent should you wish to use it.

I have reviewed the corporate file, Ms. Bomar, and found a letter dated August 31, 1981, from you to the former Secretary of State, Mrs. Frances Jones Mills, as well as an annual report form for eleven years. Copies of both are enclosed. Our records show that the corporation was credited with the \$6.00 payment (\$2.00 per year) for the years of 1978, 1979, and 1980.
