I, Shirley Jones, being duly sworn, do hereby certify that I am the duly elected and qualified Secretary of Water Works Supplies of Kentucky, Inc., a Kentucky corporation, and that the following is a true, complete and correct copy of a resolution duly adopted by the written consent of the sole shareholder of Water Works Supplies of Kentucky, Inc. on December 31, 1986, in accordance with the Kentucky statutes and by-laws of the Corporation:

RESOLVED, that the following resolution adopted by the unanimous written consent of the Board of Directors, and referred to the sole shareholder for action, be and it is hereby adopted, approved and ratified:

Plan of Liquidation and Dissolution

- 1. The plan shall be and become effective upon the approval and adoption thereof by the affirmative vote of the sole shareholder of the Corporation. The Corporation shall be dissolved as soon as practicable after adoption of this plan.
- 2. Within thirty (30) days after the date the sole shareholder adopts the plan of liquidation, counsel for the Corporation shall file Form 966 with the District Director of Internal Revenue, Cincinnati, Ohio, together with a certified copy of this resolution.
- 3. The proper officers of the Corporation shall file a Statement of Intent to Dissolve pursuant to Sections 271A.415 and 271A.425 of the Kentucky Revised Statutes with the Secretary of State of the Commonwealth of Kentucky.
- 4. James B. Taylor and/or Shirley Jones shall act for the Corporation in winding up the affairs of the Corporation.

- 5. The Corporation shall proceed as far as possible to collect all accounts receivable and to settle any claims against the Corporation.
- 6. As soon as practicable, the Corporation, by its duly authorized officers and its sole director, shall distribute all assets, subject to any unpaid liabilities, whether known or unknown, to Water Works Supplies, Inc., the sole shareholder of the Corporation, in redemption and cancellation of the outstanding capital stock of the Corporation, by appropriate instruments of transfer.
- 7. Proper officers of the Corporation and counsel shall file all other forms and documents required by the Commonwealth of Kentucky and the Federal Government, including tax returns.

- 9. The officers and sole director of the Corporation are empowered, authorized and directed to carry out the provisions of this resolution, and to adopt further resolutions that may be necessary in liquidating and dissolving the Corporation in accordance with the expressed intent of the sole shareholder under the plan adopted.
