- 1. The present name of the Corporation is: ASHLAND INC EMPLOYEES CREDIT UNION;
- 2. The name of the corporation shall be changed to:

 ASHLAND CREDIT UNION;
- 3. On July 20, 2006, the directors of the Corporation voted unanimously, pursuant to KRS 271B.10-060(5), to so change the name of the Corporation; shareholder action was not required;
- 4. Except for the change of corporate name, the Articles of Incorporation shall remain unchanged; and,

RESOLUTION AMENDING THE BYLAWS TO CHANGE THE NAME OF THE CREDIT UNION

WHEREAS, the Board discussed the Credit Union's name change. Mr. Lucas presented Management's suggested change to the Credit Union's name. Following further discussion, Mr. Ray moved to accept the following resolution (Exhibit A) amending the bylaws to change the name of the Credit Union.

WHEREAS, that the By-laws be amended by deleting "Ashland Inc Employees Credit Union" in Section 1 of Article 1 and substituting "Ashland Credit Union" therefor.

Ms. Ireland seconded the motion. Motion carried unanimously.

INTRODUCTION

On August 7, 2006, the Office of Financial Institutions ("Office") received an application from Ashland Inc Employees Credit Union, Ashland, Kentucky, ("Applicant") to amend its By-laws and Articles of Incorporation. The purpose of the amendment was to change the name of the credit union to Ashland Credit Union.

FINDINGS

- 1. The Board of Directors of the Applicant has decided to change the name of the credit union from Ashland Inc Employees Credit Union to Ashland Credit Union because the sponsor company, Ashland Inc., has sold part of its business and moved its headquarters out of Ashland. Consequently, the name change is necessary due to a change in the association with the sponsor company.
- 2. Applicant, by the required vote of the Board of Directors at a meeting duly called and held on July 20, 2006, pursuant to the provisions of Chapters 271B and 290 of the Kentucky Revised Statutes and as provided in its Bylaws, amended the articles of incorporation of the Ashland Inc Employees Credit Union. The articles were amended to change the name of the credit union from the Ashland Inc Employees Credit Union to Ashland Credit Union.'
- 3. Incorporations of state chartered credit unions are approved and recorded with the Office of Financial Institutions and not the Secretary of State. As such,

compliance with KRS Chapter 290 is required rather than KRS Chapter 271B when chartering and maintaining the corporate status of a state chartered credit union. However, through an arrangement with the Kentucky Secretary of State, OFI records information about credit unions with records of other corporations in the records of the Secretary of State's office. Consequently, credit union filings are made with the Secretary of State through OFI for informational purposes only, even though the statutes do not strictly require such filings.

4. The changes involved in a name change are strictly technical in nature. They will not have a significant impact on the Applicant and they will not impact operations in any negative way.

ORDER

The Application of Ashland Inc Employees Credit Union, Louisville, Kentucky to amend its Articles of Incorporation to change its name to Ashland Credit Union, is hereby **APPROVED**.
