The undersigned, being the President of the corporation, hereby states the followings celept: \$40.00 spenty - FAOA

- 1. The name of the corporation is Taylor Trunk Company.
- 2. Article IV is amended to read as follows:

The aggregate number of shares which the corporation shall have authority to issue is 10 shares of Class A common stock and 990 shares of Class B common stock.

Both classes of shares of the corporation shall be without distinction as to powers, preferences, and rights, other than voting rights.

Except as otherwise provided by law, voting rights upon any and all matters shall be vested exclusively in the holders of the Class A shares, and the holders of Class B shares shall have no voting rights.

- 3. All existing certificates evidencing issued and outstanding stock of the corporation, of whatever class, shall be surrendered to the corporation and exchanged for new certificates representing Class A and Class B common shares. Each current Class A common share outstanding shall be exchanged for one-tenth of one share of Class A common stock and nine-and-nine tenths of one share of Class B common stock.
- The amendment was adopted by the Board of Directors and Shareholders on August
 2000.
- 5. (a) The authorized shares of the corporation are designated as common stock.
 The number of outstanding shares of common stock is 62, all of which are entitled to vote, and all of which were represented at the meeting.

(b) The total number of votes cast for the amendment was 62; there were no votes against the amendment.


