

TO THE PROBATE JUDGE OR JEFFERSON COUNTY, ALABAMA:

UNDER AND BY VIRTUE of the Alabama Business Corporation Act, the undersigned, Albert E. Ritchey, Dec Whitley and Suc Coalson, do hereby make and file this certificate, pursuant to the provisions of said laws, to become thereunder a body corporate, for the purposes of carrying on the business hereinafter named, and hereby declars and certify as follows:

ARTICLE I

The name of the corporation shall be QUALITY MECHANICAL CONTRACTORS

ARTICLE II

The principal office of said corporation is located in Birmingham,

Jefferson County, Alabama.

ART'JLE III

The objects and purposes for which this corporation is formed are:

- (a) To engage in the plumbing, heating and air conditioning business generally, as a mechanical contractor, doing all things in connection therewith, and performing any work or business related thereto.
- (b) To conduct in connection therewith the business of buying, selling, or distributing merchandise either at wholesale or retail.
- (c) To do installation and repair work for plumbing, heating and air conditioning apparatus, and to do a general plumbing, heating and air conditioning business, to include process piping, sheet metal, utility piping and ventilation work
- (d) To buy, lease, or otherwise acquire, so far as may be permitted by law, the whole or any part of the business, goodwill, and assets of any person, firm, association, or corporation (either foreign or domestic) engaged in a business of the same general character as that for which this corporation is organized.
- (e) To the same extent as natural persons might or could do, to purchase or otherwise acquire, and to hold, own, maintain, work, develop, cell, leace, exchange, hire, convey, mortgage, or otherwise dispose of a deal in, lands, and leaseholds and any interest, estate and rights in real property, and any personal or mixed property, and any franchises, rights, licenses, or privileges necessary, convenient, or appropriate for any of the purposes herein expressed.
- (f) To buy, sell and deal in all kinds of accurities and property in its own right and from time to time to vary any investment or employment of capital of the corporation.

- (g) To borrow money and to make and issue notes, bonds, debentures, obligations and evidences of indebtedness of all kinds, whether secured by mortgage, pledge or otherwise, without limits as to amount, and to secure the same by mortgage, pledge or otherwise, and generally to make and perform agreements and contracts of every kind and description.
- (h) To acquire by purchase, subscription, or otherwise, and to hold for inventment and to use, sell, assign, transfer, mortgage, pledge or otherwise deal with or dispose of stocks, bonds, or any other obligations or securities of any corporation or corporations; to merge or consolidate with any corporation in such manner as may be permitted by laws; to aid in any manner any corporation whose stocks, bonds or other obligations are held or in any manner guaranteed by this corporation, or in which this corporation is in anyway interested; and to do any other acts or things for the preservation, protection, improvement or enhancement of the value of any such stock, bonds, or other obligations; and while owner of any stock, bonds, or other obligations to exercise all the rights, powers, and privileges of ownership thereof, and to exercise any and all voting powers thereon; to guarantee the payment of dividends upon any stock, or the principal or interest or both, of any bonds or other obligations, and the performance of any contracts.
