

FIRST:

THIRD:

The Corporation has 15,000 outstanding shares of common stock. Each such share was entitled to one vote with respect to the dissolution of the Corporation. The shareholders adopted a resolution authorizing and approving the dissolution of the Corporation by written consent on January 3, 1996, such consent being sufficient for approval.
