- Notify the Secretary of State within sixty (60) days that its registered agent or registered office had been changed, that its registered agent had resigned, or that its registered office had been discontinued; or
- Change the period of duration stated in its articles of incorporation, which has expired.

The undersigned hereby applies for reinstatement on behalf of the above named corporation and further states as follows:

- (1) The grounds for dissolution either did not exist or have been eliminated;
- (2) The corporation's name satisfies the requirements of KRS 271B.4-010; and
- (3) The corporation has not wound up or liquidated its business and affairs under KRS 271B.14-050 and notified claimants under KRS 271B.14-060 and KRS 271B.14-070.
- (4) The following documents and fees are enclosed:
 - (a) A certificate from the Kentucky Revenue Cabinet reciting that all taxes owed by the corporation have been paid; and
 - (b) The Application for Reinstatement and Annual Reports;
 - (c) A check in the amount of \$ 490.00, which includes:
 - \$ 100.00 reinstatement penalty
 - 390.00 Annual Report fees for 26 YEARS
 - Amendment to Articles of Incorporation
 - (e) Add \$ 10.00 to the total listed in Section (c) **ONLY IF** a change of registered office or registered agent, or both, has occurred, complete the enclosed Statement of Change form.
 - (d) If needed, an amendment to the articles of incorporation to extend the corporation's period of duration.


