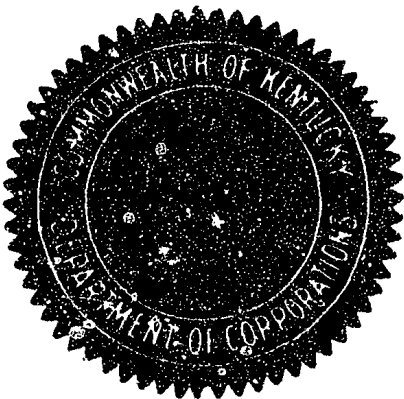

It does now represent and affirm:

(a) That the name of the corporation is SFM, INC.

(b) That the corporation has heretofore filed with the Secretary of State and with the clerk of the county court of the county in which the registered office of the corporation is situated, namely Jefferson county, a statement of intent to dissolve and the same was recorded by the Secretary of State on August 24, 1987.
