was administratively dissolved under KRS 271B.14-210 or revoked under KRS 271A.615 on **November 2, 1999** because the corporation did not:


- File its annual report for the **year 1999**;

1. the grounds for dissolution either did not exist or have been eliminated;
2. the corporation's name\* satisfies the requirements of KRS 271B.4-010; and
3. the corporation has not wound up or liquidated its business and affairs under KRS 271B.14-050 and notified claimants under KRS 271B.14-060 and KRS 271B.14-070.

The following documents and fees are enclosed with this application:

- (1) A certificate from the Kentucky Revenue Cabinet reciting that all taxes owed by the corporation have been paid;
- (2) Reinstatement Annual Report;
- (3) A check in the amount of **\$130.00** which includes:
  - (a) **\$100.00** reinstatement penalty fee;
  - (b) **\$30.00** Annual report fee for filing each delinquent annual report for **2 years**.
- (4) Form SSC-107 — Complete this form if a change has occurred to the current registered office or agent, or both. Add \$10.00 to the total listed in section (3) if the form is being filed as part of this reinstatement.
- (5) Articles of Amendment to the Articles of Incorporation —If the corporation's name is unavailable for use at the time of reinstatement, add \$40.00 to the total in section (3) if an amendment is being filed as part of this reinstatement.
- (6) Articles of Amendment to the Articles of Incorporation. —If changing the corporation's period of duration due to expiration, add \$40.00 to the total in section (3) if an amendment is being filed as part of this reinstatement.


