We, the undersigned, being the President and Secretary of the Deposit Service Corporation, do hereby certify that on the ## day of January, 1972, the shareholders of the entire voting stock of the Deposit Service Corporation consented in writing (pursuant to the provisions of KRS 271.405) to the amendment of the Articles of Incorporation of the Deposit Service Corporation as hereinafter set forth.

WHEREFORE, the Articles of Incorporation of the Deposit

Service Corporation are hereby amended so that Article I B of the

Articles of Incorporation of the company shall read as follows:

ARTICLE I B.

The purpose of the corporation shall be to engage in any commercial, industrial or agricultural enterprise, including (but its purpose shall not be limited to) the business of brokering, selling and servicing insurance in all forms; the business of purchasing, holding, leasing, selling, conveying, developing and otherwise managing (including agricultural farm management) and disposing of all kinds of property, whether real, personal or mixed, whether situated in Kentucky or in any other state of the United State; the business of acquiring, owning, selling and disposing of, and dealing in, stocks, bonds, mortgages, securities, notes and commercial paper of corporations and individuals; the business of acquiring, owning, renting, leasing, selling and

disposing of and otherwise dealing in record keeping and data processing equipment and providing record keeping and data processing services to others. And the doing of all things necessary incident to or convenient in connection with said enterprises.
