2. Forty-four Thousand Six Hundred (44,600) shares of Class A common stock have been cancelled by a resolution of the board of directors duly adopted on December 19, 1983. **327690**

3. After giving effect to such cancellation, the aggregate number of issued shares of Class A common stock is Five Thousand Four Hundred (5,400).

4. After giving effect to such cancellation, the stated capital of the corporation is \$132,964.
