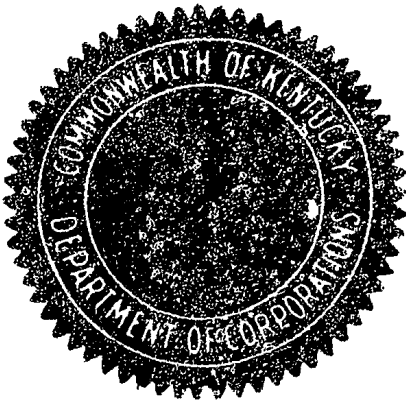

ARTICLES OF DISSOLUTION  
PURSUANT TO SECTION 92 OF THE  
KENTUCKY BUSINESS CORPORATION ACT  
OF  
CHENAULT DEVELOPMENT CORPORATION

Pursuant to the provisions of Section 92 of the Kentucky Business Corporation Act, the undersigned Corporation adopts the following Articles of Dissolution for the purpose of dissolving the Corporation:

FIRST: The name of the Corporation is Chenault Development Corporation.

SECOND: A Statement of Intent to Dissolve the Corporation was filed with the Secretary of State of Kentucky on May 16, 1988, pursuant to the provisions of Section 85 of the Kentucky Business Corporation Act.

THIRD: All debts, obligations and liabilities of the Corporation have been paid and discharged, or adequate provision has been made therefor.
