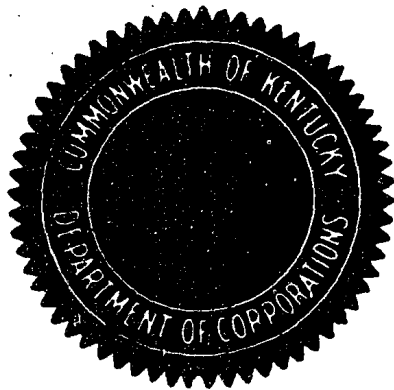

ARTICLES OF DISSOLUTION

KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, all debts, liabilities and obligations of the Blue Grass Dental Student Loan Fund Corporation, a Kentucky corporation, have been paid and discharged or adequate provision made therefor and all the remaining property and assets of the corporation distributed to the University of Kentucky Dental School, including accounts receivable,

NOW, THEREFORE, the Blue Grass Dental Student Loan Fund Corporation by the Board of Trustees acting for the corporation, hereby dissolves as a corporation under the provisions of Chapter 271a of the Kentucky Revised Statutes.

1. That the name of the corporation is the Blue Grass Dental Student Loan Fund Corporation.
2. The corporation has heretofore filed with the Secretary of State and the Clerk of Fayette County, Kentucky, in which this corporation is registered, a statement of its intentions to dissolve, such statement having been recorded in the office of the Secretary of State on the ___ day of _____, 1976.
3. All debts, liabilities and obligations of the corporation have been paid and adequate provisions made therefor.
4. All the remaining property and assets of the corporation have been distributed to the University of Kentucky Dental School, including but not limited to the accounts receivable.
5. There are no suits pending against the Blue Grass Dental Student Loan Fund Corporation in any court.


