## NOTIFICATION OF AGENT RESIGNATION

This office has received and filed written notice that the corporation's registered agent has resigned (File-stamped copy enclosed). On the thirty-first (31st) day after the date on which the statement of resignation was filed with the Secretary of State, the agency appointment will be terminated and the registered office discontinued, if so provided in the statement of resignation. (KRS 271B.5-030; KRS 271B.15-090; KRS 273.1841; KRS 273.3643)

Kentucky law requires each corporation to continuously maintain in this state a registered agent and registered office. The Secretary of State may commence a proceeding to administratively dissolve a domestic corporation or revoke the certificate of authority of a foreign corporation if the corporation is without a registered agent or registered office in this state for sixty (60) days or more.
