FIRST. The name of this corporation is SKI Enterprises, Inc.

SECOND. Its registered office in the Commonwealth of Kentucky is to be located at 2501 Logene Court, Louisville, Kentucky 40216, County of Jefferson. The registered agent in charge thereof is Jerome Alan Kasperski, address the same as above.

THIRD. The nature of the business as stated in the attached appendage titled "Articles of Incorporation and By-Laws of SKI Enterprises, Inc.," and the objects and purposes proposed to be transacted, promoted and carried on, are to engage in any lawful act or activity for which corporations may be organized under Kentucky Corporation Laws.

FOURTH. The number of of stock authorized shall be sixty (60) shares, and they shall be without par value.

SIXTH. All of the corporation's issued stock, exclusive of tressury shares, shall be held of record by not more than four (4) persons, at most.

SEVENTH. All of the issued stock of all classes shall be subject to the following restriction on transfer permitted by Section 271A270 of Kentucky Corporation Laws.

Each stockholder shall offer to the corporation or to other stockholders of the corporation a thirty (30) day "first refusal" option to purchase his stock should he elect to sell his stock.

EIGHTH. The corporation shall make no offering of any of its stock of any class which would constitute a "Public Offering" within the meaning of the United States Securities Act of 1933, as it may be amended from time to time.
