ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF KENTUCKY CONCRETE PIPE COMPANY, INC.

Pursuant to the provisions of the Kentucky Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is Kentucky Concrete
Pipe Company, Inc. 528628

SECOND: The following amendment to the Articles of Incorporation was adopted by the written consent of the shareholders of the Corporation dated June 15, 1988, after recommendation of the resolution by the unanimous written consent of the Board of Directors, in the manner prescribed in the Kentucky Pusiness Corporation Act for amending Articles of Incorporation where shares have been issued.

ARTICLE V was amended by deleting it in its entirety and by substituting the following in lieu thereof:

"The number of shares which the Corporation shall have the authority to issue is 70,000 shares of common stock, \$10 par value per share, of which 35,000 shares shall be Voting Common Stock and 35,000 shares shall be Non-Voting Common Stock. The common stock outstanding when the Articles of Amendment become effective shall be the Voting Common Stock and, at that time, each shareholder of common stock shall receive I share of Non-Voting Common Stock for each share of common stock that shareholder owns at that time.

The designations, preferences, privileges and voting powers of each class of stock of the Corporation, and the restrictions and qualifications thereof, shall be as follows:

VOTING COMMON STOCK

Voting Rights. Each holder of Voting Common Stock shall be entitled to one vote for each share held.

<u>Dividends</u>. The holders of Voting Common Stock shall be entitled to receive such dividends, as may, from time to time, be declared by the Board of Directors of the Corporation; provided, however, that whenever a dividend shall be declared by the Board of Directors of the Corporation on a share of Non-Voting Common Stock, a dividend in an equal amount per share shall be declared on Voting Common Stock.

NON-VOTING COMMON STOCK

Voting Rights. Unless otherwise required by law, no holder of Non-Voting Common Stock shall be entitled to vote.

<u>Dividends</u>. The holders of Non-Voting Common Stock shall be entitled to receive such dividends, as may, from time to time, be declared by the Board of Directors of the Corporation; provided, however, that whenever a dividend shall be declared by the Board of Directors of the Corporation on a share of Voting Common Stock, a dividend in an equal amount per share shall be declared on Non-Voting Common Stock."
