#### ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF TPA, INC.

Pursuant to the provisions of Article 4.04 of the Texas

Business Corporation Act, the undersigned corporation adopts the

following Articles of Amendment to its Articles of Incorporation,

which amend Article One thereof so as to change the name of the

corporation:

ARTICLE ONE. The name of the corporation is TPA, Inc.

ARTICLE TWO. The following amendment to the Articles of Incorporation was adopted by the shareholders of the corporation on July 28, 1982.

The amendment alters or changes Article One of the amended Articles of Incorporation and Article One is hereby amended to read as follows:

ARTICLE ONE. The name of the corporation is Third Party Administrators, Inc.

ARTICLE THREE. The number of shares of the corporation outstanding at the time of such adoption was 1,000; and the number of shares entitled to vote was 1,000.
