# AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF CITYWORKS, PLLC

Pursuant to the provisions of Chapter 275 of the Kentucky Revised Statutes, the undersigned professional limited liability company hereby amends and restates its Articles of Organization, and for that purpose submits the following statements:

- 1. The name of the limited liability company is Cityworks, PLLC. The initial Articles of Organization was filed with the Kentucky Secretary of State on November 30, 2004 ("Articles of Organization").
- 2. The Articles of Organization is hereby amended, restated, and replaced in its entity to read as follows:

## ARTICLE 1

#### **NAME**

The name of the limited liability company is Cityworks, LLC (the "Company").

#### ARTICLE II

### **PURPOSE AND POWER**

The Company shall have any lawful purpose and all the powers conferred upon a limited liability company organized under the provisions of Chapter 275 of the Kentucky Revised Statutes and shall have all powers necessary, proper, convenient or desirable in order to fulfill and further the purposes of the Company.

#### ARTICLE IV

#### **DURATION**

The Company shall commence its existence on the date these Amended and Restated Articles of Organization are filed with the Kentucky Secretary of State. The duration of the Company shall be in perpetuity

#### **ARTICLE V**

#### REGISTERED OFFICE AND AGENT

The street address of the Company's initial registered office in the Commonwealth of Kentucky shall be 815 West Market Street, Suite 110, Louisville, Kentucky 40202. The name of the initial registered agent of the company at that office is Weyland Ventures, LLC.

#### ARTICLE VI

#### **MANAGEMENT**

The management of the Company is reserved to its member(s), to be exercised in accordance with the Company's Operating Agreement. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Amended and Restated Articles of Organization.

#### ARTICLE VII

#### STATEMENT OF LIMITED LIABILITY

Except as otherwise provided by Kentucky law, no member, manager, agent, or employee of the Company shall be personally liable for the debts, obligations, or liabilities of the Company, whether arising in contract, tort, or otherwise, or for the acts or omissions of any other member, manager, agent, or employee of the Company.
