

KNOW ALL MEN BY THESE PRESENTS:

That Planters Tobacco Warehouse Company of Bowling Green,
Kentucky, Incorporated, has elected to amend its Articles of
Incorporation as provided by KRS 271.305. The information required
by KRS 271.305 is as follows:

- (a) The name of the corporation is Planters Tobacco Warehouse Company of Bowling Green, Kentucky.
- (b) A special joint meeting of the Board of Directors and shareholders of Planters Tobacco Warehouse Company of Bowling Green, Kentucky, Incorporated, was held at the office of the corporation on the 18th day of April, 1979, for the specific purpose of amending the Articles of Incorporation.
- (c) The adoption of the amendments was by resolution upon the unanimous vote of all of the shareholders and Board of Directors of Planters Tobacco Warehouse Company of Bowling Green, Kentucky, Incorporated.
 - (d) The Amendments so adopted are as follows:

Amendment I. Article II of the Articles of Incorporation shall be amended to read as follows:

The duration of the corporation shall be perpetual.

Amendment II. Article III of the Articles of Incorporation shall be amended to read as follows:

The nature of the business and the objects and purposes of the corporation shall be to buy, sell, manufacture, redry, rehandle and prize tobacco on its own account and to sell, weigh, store, rehandle, redry and prize tobacco for other persons; to transact any and all lawful business for which corporations may be organized under KRS Chapter 271A; to purchase or otherwise acquire, own, trade, deal in and deal with, mortgage, pledge, sell, assign and transfer or otherwise dispose of goods, wares and merchandise and real and personal property of every class and description; and to generally engage in, do and perform any enterprise, act or vocation that a general person might or could do or perform.

Amendment III. Article IV of the Articles of Incorporation shall be amended to read as follows:

The capital stock of the corporation shall consist of 1,000 shares of common stock, each with a par value of \$100.00, which shall constitute the total capitalization of the corporation with each share having an equal voting right.

Amendment IV. Article V of the Articles of Incorporation shall be amended to read as follows:

The registry office of the corporation shall be leasted at 1010 Gellege Street, Bowling Green, Warren County, Kentucky, and its agent shall be Robert W. Dickey, whose address is the same as that of the corporation.

Amendment V. Article VI of the Articles of Incorporation shall be amended to read as follows:

The Board of Directors of the corporation shall consist of seven (7) directors provided, however, that the number of directors may be increased or decreased in any manner provided for in the by-laws of the corporation.
