The initial registered agent of the Limited Liability Company at the same address is **MARTHA JANE SMITH**.

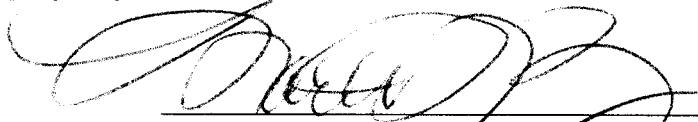
**ARTICLE III**
