

## Consent Resolution

The undersigned, being all of the Directors of Nachod & United States Signal Co., a Kentucky corporation, do hereby, pursuant to the provisions of KRS 271A.220, unanimously consent to the adoption of the following resolution:

### RESOLVED:

1. That the Articles of Incorporation of Nachod & United States Signal Co. be amended so as to delete ARTICLE VI thereof and insert in lieu of said ARTICLE VI a new ARTICLE VI reading as follows:

ARTICLE VI: The corporation shall begin business on the second day of January, 1935, and shall have perpetual existence unless sooner terminated as provided by law.

2. That a meeting of the stockholders of Nachod & United States Signal Co., being the annual 1982 meeting, is hereby called to be held on the 12th day of January, 1982, at the offices of the corporation at 125 Chenoweth Lane, Room 307, Louisville, Kentucky, for the purposes of (a) electing directors, and (b) considering an amendment to the Articles of Incorporation pursuant to which the existence of this corporation shall become perpetual unless sooner terminated as provided by law.

3. That the Secretary of this corporation is hereby authorized and directed to send to each stockholder of record of the corporation, on or before the 23rd day of December, 1981, a notice of the meeting of stockholders to (a) elect directors, and (b) consider amending the Articles of Incorporation in the manner set forth in the resolution adopted by the Board of Directors, which said notice shall be substantially as follows:

Notice is hereby given that pursuant to the action of the Board of Directors a meeting of the stockholders of this corporation, being the annual 1982 meeting, will be held at the offices of the corporation at 125 Chenoweth Lane, Room 307, Louisville, Kentucky, at 11:00 A.M. on the 12th day of January, 1982, for the purposes of (a) electing directors, and (b) considering and passing upon an amendment to the Articles of Incorporation in accordance with a resolution heretofore adopted by the Board of Directors, which amendment is to the effect that the provision of the Articles of Incorporation limiting the existence of the corporation to a period of 50 years from January 2, 1935, be deleted and in lieu thereof a provision be adopted to the effect that the existence of the corporation shall be perpetual unless sooner terminated in the manner provided by law.
