Pursuant to Section 253 of the General Corporation Law of the State of Delaware

Baker Industries, Inc., a Delaware corporation (the "Corporation"), does hereby certify:

FIRST: That the Corporation is incorporated pursuant to the General Corporation Law of the State of Delaware.

SECOND: That the Corporation owns all of the outstanding shares of each class of the capital stock of Baker Protective Services, Inc., a Delaware corporation.

THIRD: That the Corporation, by the following resolutions of its Board of Directors, duly adopted on Thursday, December 17, 1987, determined to merge Baker Protective Services, Inc. into the Corporation on the conditions set forth in such resolutions:

RESOLVED, that, effective as of 9:03 a.m. (EST) on December 31, 1987, the Corporation merge into itself its subsidiary, Baker Protective Services, Inc., and assume all of said subsidiary's liabilities and obligations; and

FURTHER RESOLVED, that the President or any Vice President and the Secretary or any Assistant Secretary of this Corporation be, and each of them nereby is, authorized to make, execute and acknowledge a certificate of ownership and merger setting forth a copy of the resolution to merge said Baker Protective Services, Inc. into this Corporation and to assume said subsidiary's liabilities and obligations and the date of adoption thereof and to file the same in the office of the Secretary of State of the State of Delaware and a certified copy thereof in the Office of the Recorder of Deeds of New Castle County, Delaware.
