The number of votes entitled to be cast on the proposal to dissolve the corporation was 100, and the number of votes cast in favor of the dissolution of said corporation was 100. 4. Purchase Equipment Company, Inc. shall not carry on any business except that business appropriate to wind up and liquidate its business and affairs pursuant to KRS 271B.14-050.


