### ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF

## SOUTH ELKHORN SERVICE COMPANY

3-31-2

KNOW ALL MEN BY THESE PRESENTS:

That Ted R. Osborn, as President, and Della W. Osborn, as Secretary of SOUTH ELKHORN SERVICE COMPANY, a Kentucky corporation, with its principal office and place of business at 100 Lowry Lane, Lexington, Kentucky, do hereby certify that at a meeting of the holder of all of the capital stock of SOUTH ELKHORN SERVICE COMPANY held on March 30, 1972, at the office of the corporation, at which meeting the sole stockholder was present and waived notice of the meeting, the following resolution and amendment to the Article; of Incorporation of South Elkhorn Service Company was unanimously adopted by a vote of the said stockholder:

BE IT RESOLVED that the Articles of Incorporation of South Elkhorn Service Company be and the same are hereby amended so as to abrogate and repeal in toto all of the provisions of Article XII thereof, and to provide instead thereof that specific article herein set forth, viz:

ARTICLE XII.

LIMIT ON INDEBTEDNESS. The highest amount of indebtedness or liability that this corporation may at any time incur shall be One Hundred Million Dollars (100,000,000,00).
