ARTICLES OF ORGANIZATION

FOR

TUCKER HOLDINGS, LLC

A KENTUCKY LIMITED LIABILITY COMPANY

The undersigned, serving as the organizer, hereby forms a Kentucky limited liability company pursuant to the Kentucky Limited Liability Company Act (the "Act"), KRS Chapter 275, as follows:

ARTICLE I

NAME

The name of the limited liability company shall be **TUCKER HOLDINGS, LLC** (the "Company").

ARTICLE II

INITIAL REGISTERED OFFICE AND INITIAL REGISTERED AGENT

The street address of the Company's initial registered office and the name of the Company's initial registered agent at that office shall be:

ARTICLE III

INITIAL PRINCIPAL OFFICE

The mailing address of the initial principal office of the Company shall be:

ARTICLE IV

MEMBERS

The Company has one (1) member, which member (and any assignees of membership interest) are bound by the terms of the Company's Operating Agreement. The

Company's Operating Agreement sets forth certain restrictions on the right(s) of its member(s) (and assignees of membership interests) to assign membership interests.

ARTICLE V

MANAGEMENT

The management of the Company is reserved to a Manager(s) elected and/or appointed by the Member(s) in accordance with the Operating Agreement of the Company. Only those elected or appointed as Manager(s) may bind the Company and no Member(s) by reason of being a Member(s) may bind the Company. The authority of the Manager(s) shall be exercised in accordance with the Operating Agreement of the Company.

ARTICLE VI

TERM

The term and existence of the Company shall be perpetual except as provided in the Company's Operating Agreement.

ARTICLE VII

LIMITED LIABILITY

Except as otherwise provided by Kentucky law, no Member, Manager, Employee or Agent of the Company shall be personally liable by reason of being a Member, Manager, Employee or Agent of the Company, under a judgment, decree, or order of a court, agency or tribunal of any type or in any other manner, in this or any other state or any other basis, for a debt, obligation or liability of the Company, whether arising in contract, tort or otherwise, or for the acts or omissions (including any negligence, wrongful act or actionable misconduct) of any other Member, Manager, Employee or Agent of the Company.

ARTICLE VIII

CONVERSION OF LIMITED PARTNERSHIP INTO LIMITED LIABILITY COMPANY

1. These Articles of Organization provisions reflect the conversion of a limited partnership into the Company as a limited liability company (the "Conversion").

2. The name of the former limited partnership was “**Tucker Holdings, Ltd**” (the “Partnership”).

3. There were 100 votes cast by the Trustees of the Joe Ben Tucker and Carolyn S. Tucker Family Trust, under Trust Agreement dated April 10, 2020, as sole partners (general and limited) of the Partnership entitled to vote for the Conversion, and no votes against the Conversion. The Conversion of the Partnership into the Company was unanimously approved by the Trustees of the Joe Ben Tucker and Carolyn S. Tucker Family Trust, under Trust Agreement dated April 10, 2020, as the sole general and sole limited partner of the Partnership.

ARTICLE IX

ORGANIZER
