Dear Corporate Agent:

The records of the Secretary of State show that you filed an Intent to Dissolve, but have not filed an Annual Verification Report as required by KRS 2718.16-220 and its predecessor, KRS 271A.615(1). The Revenue Cabinet advises that they have found that tax liability exists for the corporation. .

In order to dissolve the corporation you should file the annual reports for 1986, 1987, 1988, 1989 , and pay the fee of \$ 40.00 . You are also required by KRS 271B.14-030 to file Articles of Dissolution. The fee to dissolve a corporation under KRS Chapter 2718 is \$40.00. Your total remittance is \$ 80.00

If you wish to continue the business, you must file the annual reports with the fee of \$40.00 , and revoke the Statement of Intent to Dissolve (KRS 271A.440 - .445) with the fee of \$15.00. Your total remittance to stay in good standing is \$ 55.00 .

Please make your check payable to the Kentucky State Treasurer, and mail to BREMER EHRLER, Secretary of State, P.O. Box 718, Frankfort, KY 40602-0718.

MOTICE: Failure to file an annual verification report within sixty days after it is due will result in administrative dissolution pursuant to KRS 271B.14-210.
