ARTICLES OF DISSOLUTION OF THE WRIGHT MACHINE COMPANY

- 1. The name of the corporation is THE WRIGHT MACHINE COMPA-NY.
- 2. Dissolution of the corporation was authorized on April 18, 1992 and is effective on the date of filing these Articles of Dissolution with the Secretary of State of Kentucky.
- 3. This dissolution was authorized and approved by a majority of all votes entitled to be cast on the proposal, there being 760 shares of issued and outstanding common stock of the corporation entitled to vote, with a majority of such shares being cast for dissolution. The total number of undisputed votes cast for dissolution was 455, and the number cast for dissolution was sufficient for approval.
- 4. There are no other classes of stock other than the common stock and no other stock entitled to yote.
- 5. The corporation will wind up and liquidate its business and affairs effective on the earlier of the date of filing these Articles with the Secretary of State of Kentucky, or December 31, 1992, and the share transfer record books of the corporation shall be closed effective on such date.
- 5. All debts, obligations and liabilities of the corporation have been paid and discharged, or adequate provision has been made therefor.

- 7. All remaining property and assets of the corporation have been distributed among the corporation's shareholders in accordance with their respective rights and interests.
- 8. There are no suits pending against the corporation in any court.
