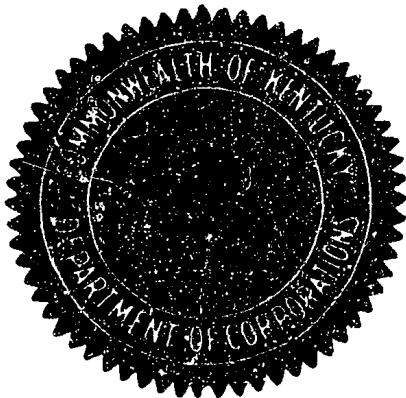

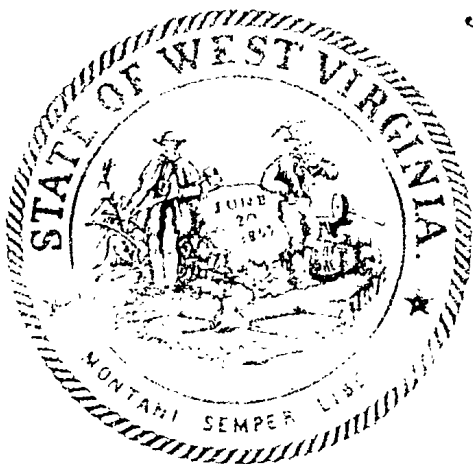

Pursuant to the provisions of Section 31, Article 1, Chapter 31 of the Code of West Virginia, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Charleston Linen Service, Inc.

SECOND: The following Amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on September 22, 1986, in the manner prescribed by Sections 107 and 147, Article 1, Chapter 31.

RESOLVED: That the articles of incorporation of the corporation be amended to read as follows:

The name of the corporation shall be Chartex Services, Inc.

THIRD: The number of shares of the corporation outstanding at the time of such adoption was 100; and the number of shares entitled to vote thereon was 100.

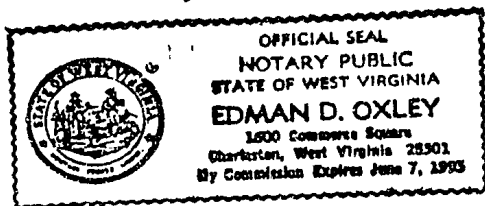
