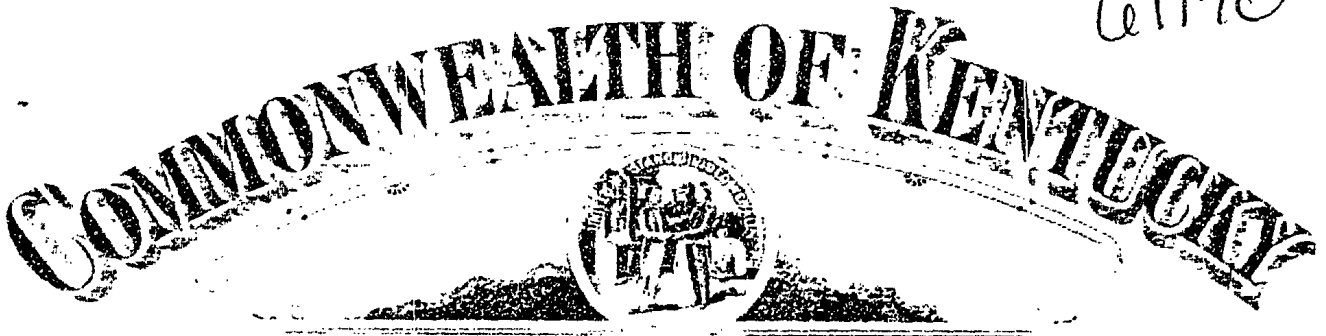

INSTRUCTIONS

The *Corporate Name* must be the exact name as the corporation is transacting business under in the State of Kentucky, or the fictitious name adopted for use in the state by resolution of its board of directors if "real name" was unavailable.

The *Application for Certificate of Withdrawal* shall be signed by a corporate officer or the chairman of the board of directors.

Submit one (1) original signed and two (2) exact or conformed copies of the application. (May be photocopies.)

Filing Fee: \$40.00 - profit, stock corporation (KRS Chapter 271B)

\$ 8.00 - non-profit, non-stock corporation (KRS Chapter 273)

Make check payable to the "Kentucky State Treasurer."

Two (2) file stamped copies of the application shall be returned to the corporation as evidence of filing. One file stamped copy shall then be filed with the county clerk of the county in which the corporation's registered office is situated. YOUR FILE STAMPED COPY SHALL SERVE AS THE CERTIFICATE OF WITHDRAWAL.
