Submit one (1) original signed and two (2) exact or conformed copies of the application. (May be photocopies.)

Filing Fee: X \$40.00 - profit, stock corporation (KRS Chapter 271B)

\$ 8.00 - non-profit, non-stock corporation (KRS Chapter 273)

Two (2) file stamped copies of the application shall be returned to the corporation as evidence of filing. One file stamped copy shall then be filed with the county clerk of the county in which the corporation's registered office is situated.
