The undersigned person desiring to form a Kentucky limited liability company (hereinafter referred to as the "Company" pursuant to the provisions of the Kentucky Limited Liability Company Act, KRS 275, executes the following Articles of Organization:

ARTICLE I - Name

Limited Liability Company Act and the operating agreement of the limited liability company.

ARTICLE VIII - Limited Liability

Except as otherwise provided by Kentucky law, no member, manager, agent or employee of the Company shall be personally liable for the debts, obligations, or liabilities of the Company, whether arising in contract, tort or otherwise, or for the acts or omissions of any other member, manager, agent or employee of the Company.






