ARTICLES OF DISSOLUTION

Know All Men By These Presents:

Whereas all debts, liabilities and obligations of Nationwide Realty Service Co., a Kentucky corporation, have been paid and discharged or adequate provision made therefor and all remaining property and assets of the corporation distributed to its shareholders.

Now, therefore, the Nationwide Realty Service Co., by Willard F. Schiesz, its President and William E. Schiesz, its Secretary, hereby dissolves as a corporation under the provisions of Chapter 271 of the Kentucky Revised Statutes. 470003
