

The undersigned, acting as the sole incorporator of a corporation for profit under the Kentucky Business Corporation Act, does hereby adopt the following Articles of Incorporation for WHITESBURG SEAFOOD, INC.

FIRST: The name of the corporation shall be WHITESBURG SEAFOOD, INC.

SECOND: The period of duration of the corporation shall be perpetual.

THIRD: The purpose or purposes for which the corporation is organized shall be the transaction of any or all lawful business for which corporations may be incorporated under the Kentucky Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is Two Thousand (2,000) shares all of which shall be designated Common Shares and shall be without par value.

No shareholder shall have the right or power to pledge, hypothecate, sell or otherwise dispose of any share of the Common Stock without par value of this corporation without first offering said shares for sale or other disposition to the other shareholders of this corporation or to the corporation, under such terms and conditions as may be set forth in the By-Laws of this corporation.
