ARTICLE OF INCORPORATION
OF
BRIGHT AND LOGSDON DEVELOPERS, INC.

KNOW ALL MEN BY THESE PRESENTS:

That I, ROGER A. BRIGHT, of Jefferson County, Kentucky, do hereby form a corporation under the laws of the State of Kentucky.

ARTICLE I The name of the Corporation shall be Bright and Logsdon Developers, Inc.

(Continued)

ARTICLE II. Its purpose shall be to develop, buy and sell real estate and to construct all kinds of improvements thereon, and to do every and all other things necessary and incidental to the operation of such a business.

ARTICLE III Its duration shall be perpetual.

ARTICLE IV Its registered office shall be 1303 Clear Springs Trace, Louisville, Kentucky; its registered agent shall be Roger A. Bright, 1303 Clear Springs Trace, Louisville, Kentucky.

ARTICLE V The capital stock of the corporation shall be ONE THOUSAND DOLLARS (\$1,000.00), all of which shall be common stock. It shall consist of TEN SHARES (10) of no par value stock. Each share shall be entitled to one (1) vote.

ARTICLE VI The Corporation will begin business with not less than ONE THOUSAND DOLLARS (\$1,000.00).

ARTICLE VII The name, residence and number of share of stock subscribed by the incorporator are as follows:

Bright, 1503 Clear Spring Trace, Louisville, Kentucky; Wesley A. Johnson, 1507 Clear Spring Trace, Louisville, Kentucky; and Don Groole, 1509 Clear Spring Trace, Louisville, Kentucky.

ARTICLE IX The Corporation shall not incur an indebtedness exceeding TEN MILLION DOLLARS (\$10,000,000.00).




