ARTICLES OF INCORPORATION

and acting as incorporator of a corporation under the Kentucky Business Corporation Act, hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is Oak Development Company, Inc.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which this corporation is organized is to transact any and all lawful business for which corporations may be incorporated under the Kentucky Business Corporation Act, including the purchasing, holding and developing of real eastate in the State of Kentucky, or elsewhere, including the leasing, renting, managing, controlling, owning and selling buildings and structures and said corporation shall have the authority to buy, sell, lease, hold and rent real and personal property for this corporation and others, and said corporation shall have the authority to buy, sell, convey, lease, pledge, mortgage, exchange, assign or otherwise acquire, hold and dispose of, handle and otherwise deal in and with real and personal property or any interest therein of whatever name, nature, and description, and whereever the same may be situated, either within or without the Commonwealth of Kentucky, and to exercise unlimitedly all rights and powers incident to the acquisition or desirable to protect or enhance directly or indirectly the value of any interest owned by the corporation or in which it may have any beneficial

interest or rights; to horrow money, credit or property, to make contracts and to incur obligations and to secure the same by mortgage or pledge of all or part of its assets or franchises; to act for others in any capacity or manner, to participate with others and to merge or to consolidate with other concerns in any business, enterprise or transaction which the company is authorized to engage in, in any manner and on any terms; to buy, sell, pledge, exchange, assign or otherwise acquire, hold and dispose of stocks, bonds and negotiable securities; and to do any and all other acts consistent with the purposes hereinabove set forth, as now or hereafter authorized by law for a corporation, it being the intention that the innumeration of specific powers shall not operate to limit in any manner the general powers conferred upon corporations by the laws of the Commonwealth of Kentucky.

ARTICLE IV

The total number of shares authorized to be issued and the authorized class thereof shall be One Thousand (1,000) Shares of common stock, and said shares shall be of no par value. The voting of such stock shall be one vote per share.

ARTICLE V

The address of the registered office of said corporation shall be 100 East Main Street, Frankfort, Kentucky 40601, and the name and address of the process agent of the corporation is Paul C. Gaines III, 100 East Main Street, Frankfort, Kentucky 40601.

ARTICLE VI
