purpose of forming and does hereby form a corporation under
the laws of the Commonwealth of Kentucky in accordance with
the following provisions:

ARTICLE I

Name

The name of the corporation is Castleton Stud, Inc.

ARTICLE II

Purposes

The purposes of the corporation are:

- 1. To engage in the purchase and sale of horses; the syndication of horses and the purchase and sale of shares in syndications; and the purchase and sale of real property.
- 2. To engage in any or all business enterprises for which corporations may be organized and which the Board of Directors may deem beneficial, profitable and in the best interests of the corporation, and to do all other things deemed by the Board of Directors to be necessary or desirable in connection with any of the corporation's businesses.

ARTICLE III

Powers

The corporation shall have all the powers conferred upon a corporation organized under the provisions of Chapter
