

CORRECTIONS AND AMENDMENTS TO
CERTIFICATE OF LIMITED PARTNERSHIP
OF WILDWOOD APARTMENTS, LTD.

Wildwood Apartments, Ltd., a Kentucky limited partnership (the "Partnership"), files this document to correct and amend its Certificate of Limited Partnership:

Recitals

- A. The name of the Partnership is Wildwood Apartments, Ltd.
- B. The Partnership's initial Certificate of Limited Partnership was filed on September 28, 1978 in the Laurel County Clerk's Office in Miscellaneous Instruments Book 3, page 197 and on September 8, 1978 in the Fayette County Clerk's Office in Miscellaneous Book 96, page 281.
- C. The Partnership's Statement of Assumed Name was filed on September 7, 1978 in both the Office of the Secretary of State and in the Fayette County Clerk's Office.
- D. The Partnership's first Amended Certificate of Limited Partnership was filed on December 28, 2000 in the Office of the Secretary of State.

Articles of Correction

- 1. The Partnership's Certificate of Limited Partnership contains an inaccuracy.
 - a. This inaccuracy was the result of the Partnership not filing in the Office of the Secretary of State and in the Fayette County Clerk's Office, a second amendment to its Certificate of Limited Partnership made on _____, 2006 by an Amendment to Limited Partnership Agreement, Amendment to Certificate of Limited Partnership, and Consent.
 - b. This inaccuracy is being corrected by attaching a copy of that document to these Amendments and Corrections as Exhibit A.

2. The Partnership's Certificate of Limited Partnership contains another inaccuracy.
 - a. This inaccuracy was the result of the Partnership not filing in the Office of the Secretary of State and in the Fayette County Clerk's Office, an amendment to its Certificate of Limited Partnership made on March 25, 2008 by the Third Amendment and Restated Certificate of Limited Partnership.
 - b. This inaccuracy is being corrected by attaching a copy of that document to these Amendments and Corrections as Exhibit B.

Articles of Amendment

1. The Partnership's Certificate of Limited Partnership was changed by a Statement of Change of Principal Office filed on February 28, 2012 in the Office of the Secretary of State.
2. The Partnership's Certificate of Limited Partnership was changed by a Statement of Change of Registered Office, Registered Agent, or Both filed on January 23, 2014 in the Office of the Secretary of State.
3. The Partnership's Certificate of Limited Partnership, as previously amended, is being further amended by these Articles of Amendment as follows:
 - a. Hahn Williams Mullis, Inc., a Kentucky corporation having its principal office at 2365 Harrodsburg Road, Suite B210, Lexington, Kentucky 40504, has been admitted as a new general partner.
 - b. J. Pat Williams was dissociated from the Partnership as a general partner upon his death; and Harold H. Mullis and Lisa H. Acree were dissociated from the Partnership as general partners by notifying the Partnership of their express will to withdraw as general partners upon the admission of Hahn Williams Mullis, Inc. as a general partner.

c. The Partnership elects to become subject to the Kentucky Uniform Limited Partnership Act (2006).
