

#### ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, J. DAVID GRISSOM and DAVID A. JONES, both of 200 West Broadway, Louisville, Jefferson County, Kentucky, do hereby associate for the purpose of forming a corporation under and by virtue of the laws of the Commonwealth of Kentucky and do hereby adopt the following Articles as and for its charter:

#### ARTICLE I

The name of the corporation shall be MEIDINGER AND SEAL - MIDWEST, INC.

#### ARTICLE II

The objects and purposes of the corporation shall be:

- (1) To engage in the business of offering consulting and actuarial services in the employee benefit field;
- (2) To acquire, hold, use, lease, sell or convey property, both real and personal, tangible and intangible.
- (3) To buy, sell, hold and otherwise deal in bonds, mortgages, notes, stocks, contracts, securities and other evidence of indebtedness.
- (4) To issue negotiable paper and other evidence of indebtedness, both secured and unsecured, and to mortgage or pledge its holdings, real and personal, as security, to negotiate

loans for others, to lend the corporation's credit and to guarantee and endorse and underwrite the obligations and contracts for other parties.

(5) To engage in all undertakings related to the foregoing particular purposes and in such other enterprises as may be
authorized by the Board of Directors and not in violation of the
laws of Kentucky.

#### ARTICLE III

The duration of the corporation shall be perpetual.

#### ARTICLE IV

The registered office of the corporation shall be located at 200 West Broadway, Louisville, Kentucky. The resident agent of the corporation shall be J. DAVID GRISSOM, 200 West Broadway, Louisville, Kentucky.

#### ARTICLE V

The total authorized number of shares of stock shall be ONE THOUSAND (1,000) shares without par value.

#### ARTICLE VI

There shall be but one class of stock, namely Common Stock, and all of the shares of stock shall be without distinction as to designations, powers, preferences, rights and qualifications. Holders of the capital stock of the corporation shall enjoy pre-emptive rights to acquire additional shares of capital stock.

#### ARTICLE VII

The corporation will begin business with a capital and surplus of not less than ONE THOUSAND DOLLARS (\$1,000.00).

#### ARTICLE VIII

The affairs of the corporation shall be managed by a Board of Directors composed of seven (7) Directors.

#### ARTICLE X

The Board of Directors of the Corporation shall have full power to make determinations of value for services or property taken in consideration for shares as set forth in Kentucky Revised Statutes Section 271,195.
