## RESCLUTIONS PROPOSED TO BE ADOPTED BY THE MEMBERSHIP OF CENTRAL AND SOUTHERN MOTOR FREIGHT TARIFF ASSOCIATION, INC. ATLANTA, GA -- JUNE 1, 1988

- 1. "BE IT RESOLVED, that we the members of the Association in meeting assembled this date do, after due consideration, hereby find and determine that it is in the best interest of the Association that the Association shall merge into the Conference, as outlined in the Statement of the Proposed Merger of Central and Southern Motor Freight Tariff Association, Inc., into Southern Motor Carriers Rate Conference, Inc., appended to this Notice and made part hereof;
- 2. "FURTHER RESOLVED, that the members of the Association do hereby ratify, confirm, approve, and adopt the Resolutions adopted by the Directors of the Association at a meeting held on April 26, 1988, as spread on the minutes of said meeting (hereinafter referred to as the "CSA Resolutions"), which were presented and considered at this meeting, as fully and completely as if said CSA Resultions were spread on the minutes of this meeting;
- 3. "FURTHER RESOLVED, that the members of the Association do hereby ratify, confirm, approve, and adopt the Joint Report by the Merger Committees of the Board of Governors of the Conference and the Board of Directors of the Association enclosed with the Notice of the Meeting (hereinafter called the "Joint Report"), which were presented and considered at this meeting, as fully and completely as if said Joint Report was spread on the minutes of this meeting;
- 4. "FORTHER RESOLVED, that the members of the Association do ratify, confirm, approve, and adopt the proposed By-Laws and ratemaking procedures of the Conference appended to the Joint Report and enclosed with this Notice of Meeting (hereinafter called the "By-Laws"), which were presented and considered at this meeting, as fully and completely as if said By-Laws, including the ratemaking procedures, were spread on the minutes of this meeting; and

- 5. "FURTHER RESOLVED, that without limiting the generality of the foregoing Resolutions, the President and Managing Director of the Association are hereby authorized and empowered to file and/or cause to be filed all applications required by the Interstate Commerce Commission and/or other governmental agency, whether it be a Federal or State Agency, and to execute all petitions, applications, or any other instruments in writing and to take all other actions which they may deem necessary, required, or desirable in the matter in order to effectuate the purposes of these Resolutions and effect the aforementioned merger of the Association into the Conference and to pay all costs, fees, and expenses, all as will be evidenced by the acts of said officers or Executive Committee, all of which acts, deeds, and determinations are hereby ratified, confirmed, approved, and adopted;
- 6. "FURTHER RESOLVED, that the members of the Association do hereby approve, ratify, and adopt the Agreement for Plan of Merger and dissolution previously submitted to the: and
- 7. "FURTHER RESOLVED, that the merger shall be consummated by (i) the liquidation and dissolution of Central and Southern Motor Freight Tariff Association, Inc.; (ii) the concurrent transfer to the Conference of the assets of Central and Southern Motor Freight Tariff Association, Inc.; and (iii) the assumption by the Conference of all of the obligations and liabilities of Central and Southern Motor Freight Tariff Association, Inc."

After discussion, MOTION WAS ADOPTED with 20 For and None Against by hand vote and 49 For and 1 Against by proxy vote that the aforesaid seven resolutions be and hereby are approved, ratified and adopted.
