ARTICLES OF INCORPORATION

Pursuant to §273.161 et seq. of the laws of Kentucky, the undersigned majority are citizens of the United States and residents of the state of Kentucky, do hereby submit these Articles of Incorporation for the purpose of forming a nonprofit corporation. The effective date of incorporation shall be upon filing with the Secretary of State.

ARTICLE I

NAME

The name of this nonprofit corporation shall be Allen County-Scottsville Athletic Boosters, Inc. The business of the corporation shall be conducted under the name as selected.

ARTICLE II

DURATION

The period of duration of the corporation is perpetual.

ARTICLE III

PURPOSE

The Allen County-Scottsville Athletic Boosters, Inc. is a nonprofit volunteer organization composed of parents, staff and other interested parties who objective is to enrich the Allen County-Scottsville athletic programs as well as the community. Our mission is to raise funds to enhance and expand our athletic programs, support the athletes, their coaches, and the administration, in order to allow the Allen County-Scottsville athletes to achieve their full potential. While the Allen County-Scottsville Athletic Boosters, Inc. primarily exists to assist our athletic programs with financial support, the Allen County-Scottsville Athletic Boosters, Inc.

also strives to promote good sportsmanship, high ideals of character and academic achievement. Through these characteristics, the Allen County-Scottsville Athletic Boosters, Inc. recognizes that the experience of participation in school athletics strengthens relationships and benefits many, not just the individual student, but each team, the student body, the staff, parents and the surrounding community. The corporation is organized and will be operated exclusively for charitable and educational purposes within the meaning of 501(c)(3) of the Internal Revenue Code. (All references to sections in these Articles refer to the Internal Revenue Code of 1986 as amended or to comparable sections of subsequent internal revenue laws.) In pursuance of these purposes the Corporation shall do all things necessary, proper and consistent with securing and maintaining tax exempt status under section 501(c)(3).

ARTICLE IV **MEMBERSHIP**

This corporation shall be comprised of members whose rights and qualification are determined in the manner set forth in the Bylaws.

ARTICLE V **NONPROFIT NATURE**

Allen County-Scottsville Athletic Boosters, Inc. is a nonprofit corporation. No part of the net earnings of the corporation shall inure to the benefit of or be distributed to any director, employee or other individual, partnership, estate, trust or corporation having a personal or private interest in the corporation. Compensation for services actually rendered and reimbursement for expenses actually incurred in attending to the affairs of this corporation shall be limited to reasonable amounts. No activities of the corporation shall include the carrying on of propaganda or otherwise attempting to influence legislation. Further, this corporation shall not intervene in

(including the publishing or distributing of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of this document, the corporation shall not carry on any other activities not permitted to be carried on (a) by any organization exempt from federal income tax under section 501 (c)(3) of the Internal Revenue Code, corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE VII
BOARD OF DIRECTORS

Allen County-Scottsville Athletic Boosters, Inc. shall be governed by its board of directors as described in the Bylaws. The number of directors constituting the initial Board of Directors is fourteen (14), who are to serve as the initial directors until the first annual meeting, or until their successors are elected and qualified in the manner stated in the Bylaws. The members of the Board of Directors beyond the initial directors shall be those individuals selected by the members in accordance with the Bylaws and are not limited in number by these Articles. The formula for determining the number comprising the Board is set forth in the Bylaws.

ARTICLE VIII **DISTRIBUTION UPON DISSOLUTION**

Upon the dissolution of the corporation, after paying or making provisions for the payment of all the legal liabilities of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such

organization or organizations, as said court shall determine which are organized and operated exclusively for such purposes.

ARTICLE IX
PERSONAL LIABILITY

No officer or director of this corporation shall be personally liable for the debts or obligations of Allen County-Scottsville Athletic Boosters, Inc. of any nature whatsoever, nor shall any of the property or assets of the officers or directors be subject to the payment of the debts or obligations of this corporation.

ARTICLE X
APPOINTMENT OF REGISTERED AGENT

The registered agent is Brian Carter, who is a resident of the state of Kentucky and a director of the corporation, and the address of the initial registered office shall be:



