

- (4) The par value of the shares of this credit union shall be \$5.00.
- (5) The field of membership shall be limited to those having the following common bond: Employees of the Jefferson County Police Department who work in Jefferson County, Kentucky; employees of this credit union; persons retired as pensioners and/or annuitants under private pension plans provided for the above employee groups; members of their immediate families; and organizations of such persons.

- (6) The term of this credit union's existence shall be perpetual: Provided, however, That upon the finding that this credit union is bankrupt or insolvent or has violated any provision of this organization certificate, of the bylaws, of the Federal Credit Union Act including any amendments thereto or thereof, or of any regulations issued thereunder, this organization certificate may be suspended or revoked under the provisions of Section 21(b) of the Federal Credit Union Act.
- (7) This certificate is made to enable the undersigned to avail themselves of the advantages of said Act.
- (8) The management of this credit union, the conduct of its affairs, and the powers, duties, and privileges of its directors, officers, committees and membership shall be set forth in the approved bylaws and any approved amendments thereto or thereof.

Dear Mr. Eskridge:

The certificate of approval for the change of name amendment recently requested is enclosed.

This amendment may be adopted by resolution of the board of directors in accordance with Article XXI, section 1, of the bylaws. Further approval by this office is not required as long as no changes are made to the enclosed amendment.

Please understand that a change in your corporate title from Jefferson County Police and Employees Federal Credit Union to Jefferson County Federal Credit Union, does not constitute an expansion of your field of membership (FOM). However, it should be noted that the wording in your FOM may no longer be a true definition, due to sponsor corporate changes. Your credit union's FOM is stated in section 5 of your charter. That wording should be followed precisely in screening membership applications and in advertising to the general public. You may document your request to amend your existing FOM with a letter from the sponsor, a newspaper article, or a press release, etc., explaining the sponsor's new corporate structure. This amendment should be submitted to our office within 30 days of this letter.

Note: It is the responsibility of your credit union to ensure that the name change does not constitute an infringement on the name of any corporation in your trade area. This responsibility also includes researching any service marks or trademarks used by any other credit union in the trade area. My approval is contingent upon your compliance with these requirements.

The completed form, signed by the chief executive officer and secretary of the board of directors, must be filed with the credit union's official charter/bylaws. The board of directors' minutes, the official charter/bylaws, and any resolutions adopted by the board will be reviewed by our examiners as a part of each supervisory examination.

Questions or revisions to the amendment should be directed to the Division of Insurance in this office. Please advise if we may be of any further assistance.
