

ARTICLES OF ORGANIZATION

OF

Vape City Wholesale, LLC

The undersigned, serving as organizer, hereby forms Vape City Wholesale, LLC, a Kentucky limited liability company (the "Company") pursuant to the Kentucky Limited Liability Company Act (the "Act"), KRS Chapter 275, as follows:

1. **Name**: The name of the Company is Vape City Wholesale, LLC.
2. **Initial Registered Office and Agent**: The street address of the Company's initial registered office is 1304-A Chestnut Street, Murray, KY 42071. The name of its initial registered agent at that office is Fahmi Saleh Kassim.
3. **Initial Principal Office**: The mailing address of the initial principal office of the Company is 1304-A Chestnut Street, Murray, KY 42071.
4. **Statement of Management**: The Company is to be managed by one or more managers, to be exercised in accordance with the Company's operating agreement.
5. **Dissolution**: The Company does not have a specific date of dissolution. The Company shall dissolve as provided in the Act and the Company's operating agreement.
6. **Statement of Limited Liability**: Except as otherwise provided by Kentucky law, no member, manager, agent or employee of the limited liability company shall be personally liable for the debts, obligations, or liabilities of the Company, whether arising in contract, tort or otherwise, or for the acts or omissions of any other member, manager, agent or employee of the Company.

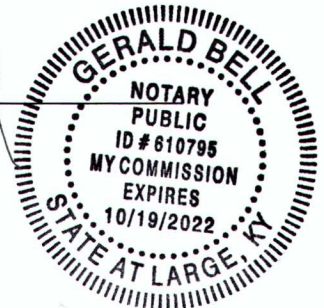




CONSENT OF REGISTERED AGENT
