# **ARTICLES OF ORGANIZATION**

of

**THE TINKER GARAGE, LLC**

**A KENTUCKY**

**LIMITED LIABILITY COMPANY**

The undersigned, Sydney Carlson, executes these Articles of Organization for the purpose of forming and does hereby form a limited liability company under the laws of the Commonwealth of Kentucky in accordance with the following provisions.

## **ARTICLE 1**
