TO THE SECRETARY OF STATE OF THE COMMONWEALTH OF KENTUCKY:

Pursuant to Section 275.360 of the Kentucky Limited Liability Company Act, the undersigned limited liability companies adopt the following Articles of Merger:

2. The surviving organization shall be: Hearth & Home Technologies LLC, a limited liability company, the jurisdiction of the governing statute of which is Iowa (the "Surviving Entity").
3. No changes to the articles of organization of the Surviving Entity will occur as part of this merger.
4. The date the merger is effective shall be 12:01 AM Central Standard Time on December 31, 2022.
5. The merger was approved as to the Surviving Entity as required by Section 489.1003 of the Iowa Revised Uniform Limited Liability Company Act.
6. The merger was approved as to Monessen Hearth Systems Company, LLC as required by Section 275.350 of the Kentucky Limited Liability Company Act.
7. The Surviving Entity agrees that it may be served with process in the Commonwealth of Kentucky in any proceeding for enforcement of any obligation of any constituent business entity party to the merger that was organized under the laws of the Commonwealth of Kentucky, as well as for enforcement of any obligation of the Surviving Entity arising from the merger.
8. The Surviving Entity appoints the Secretary of State as its agent for service of process in any proceeding described in Section 7 of these Articles of Merger. 
