The corporation will not engage in propaganda or political campaigns and will not carry on activities outside those permitted for 501(c)(3) organizations. Upon dissolution, assets will be distributed to exempt organizations or government entities for public purposes, or by court order to a qualifying organization. Change Collective is dedicated to amplifying the voices of families, caregivers, and communities to foster collaboration, empowerment, and positive social change.**
