COMMONWEALTH OF KENTUCKY ARTICLES OF MERGER

Pursuant to Section 275.360 of the Kentucky Limited Liability Company Act (the "Act"), Groome Industrial Service Group, LLC, a New Jersey limited liability company (the "**Company**"), in connection with the merger of Dos Viejos Amigos, LLC, a Kentucky limited liability company ("**DVA**") with the Company (the "**Merger**"), hereby certifies the following information relating to the Merger on February 28, 2024:

1. The name of each constituent business entity is Groome Industrial Service Group, LLC, a New Jersey limited liability company, and Dos Viejos Amigos, LLC, a Kentucky limited liability company (the "**Constituent Companies**").

2. The Company shall be the surviving business entity in the Merger. The name of the surviving business entity shall be Groome Industrial Service Group, LLC.

3. An Agreement and Plan of Merger, dated as of February 26, 2024 (the "**Merger Agreement**"), by and between the Company and DVA, has been approved, adopted, certified, executed, and acknowledged by each of the Constituent Companies in accordance with Section 275.350 of the KLLCA.

4. No changes to the Certificate of Formation of the Company are desired in connection with the Merger, so the Certificate of Formation of the Company, as in effect immediately prior to the effective time of the Merger, shall be the Certificate of Formation of the surviving company.

5. The merger is to become effective as of March 1, 2024 at 12:01 a.m. Eastern Time.

6. An executed copy of the Merger Agreement is on file at 22 Audrey Place, Fairfield, NJ 07004, the principal place of business of the surviving company.

7. A copy of the Merger Agreement will be furnished by the surviving company on request, without cost, to any member of DVA.


8. The Company hereby agrees that it may be served with process in the Commonwealth of Kentucky in any proceeding for enforcement of any obligation of DVA, as well as for enforcement of any obligation of the Company arising from the merger.

9. The Company hereby appoints the Secretary of State of the Commonwealth of Kentucky as its agent for service of process in any proceeding referenced in paragraph 8 hereto. The address to which a copy of the process shall be mailed to it by the Secretary of State is 22 Audrey Place, Fairfield, NJ 07004.
