# Nonprofit Corporation

Pursuant to KRS 14A and KRS 273, the undersigned applies to qualify and for that purpose submits the following statements:

#### 1. Name

The name of the Church (corporation) is:

#### 2. Purpose

The Church is organized exclusively for religious, charitable, and educational purposes under section 501(c)(3) of the Internal Revenue Code, including, without limitation, the participation of the Church in any or all other lawful activities (including taxable activities) to the extent the activities are permissible for a church exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code and to which contributions are deductible under section 170(c)(2) of the Internal Revenue Code.

More particularly, but without limitation, the purposes of the Church are:

- To be an instrument of God to evangelize Kentucky and the World;
- To be a channel for God and to build a body of believers being complete in the image of Christ,
- (c) To fulfill the Great Commission of Jesus Christ;

- (d) To establish and operate a Church;

- (f) To reach out to our community through evangelism, community service, and special ministries;
