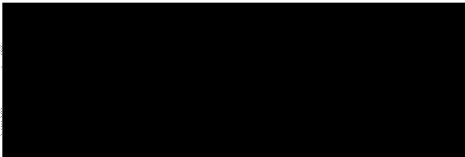

Based upon the Department of Revenue records and the information submitted, **B. M. F.
