The incorporator, whose name is hereunto signed, has executed these Articles of Incorporation for the purpose of forming a non-stock, non-profit corporation under the laws of the Commonwealth of Kentucky in accordance with the following provisions:

ARTICLE I

596797

The name of the corporation shall be American Saddlebred Horse Association Foundation, Inc.

ARTICLE II

The duration of the corporation shall be perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized shall be exclusively charitable, educational and scientific within the meaning of section 501(c)(3) of the Internal Revenue Code.

The corporation shall be operated, supervised or controlled by the American Saddlebred Horse Association, Inc., an Internal Revenue Code section 501(c)(5) organization incorporated under the laws of Kentucky.

To that end the corporation shall have the purposes of educating the general public in the exhibiting, use and history of American Saddlebred horses and the improvement of the breed;

encouraging safe equestrian activities; educating youth with respect to safe and proper horsemanship and the showing of the horses by promoting the formation of youth organizations and the dissemination of educational materials; and awarding scholarships to participants in youth horse programs.

To that end the corporation shall have all the powers of a non-stock, non-profit corporation enumerated in KRS Chapter 273.

#### ARTICLE IV

No part of the corporation's net earnings shall inure to the benefit of any member, director or officer of the corporation or to any private individual, and no member, director, or officer or any private individual shall be entitled to share in the distribution of corporate assets on dissolution of the corporation.

#### ARTICLE V

No part of the activities of the corporation shall consist of carrying on propaganda or otherwise attempting to influence legislature.

#### ARTICLE VI

The registered and principal office of the corporation shall be located at Kentucky Horse Park, 4093 Iron Works Pike, Lexington, KY 40511, and the resident agent thereat upon whom process may be served shall be Patricia G. Nichols.


**ARTICLE XI**


